

Google, as you may know has been in the news a **LOT** lately. And it's **not** because of all the wonderful things they're doing there at Google.

The problem is, no matter how many of these fines are slapped on Google, given Google's massive cash position gained through its illegal and monopolistic practices, Google's "algorithm" is to delay the regulator's process to the maximum extent possible, then challenge the adverse ruling, then "hire" more internal lawyers to fight the adverse ruling (using money owed to people that they have harmed) [In 2014, Google had 435 lawyers on its staff...Google has not disclosed an updated herd count since then, but given the huge amount of regulatory actions, one can easily surmise that number is substantially below the actual], and of course, Google chooses **not** change its illegal behaviors until FORCED to do so, simply because those monopolistic and predatory practices make Google a LOT of money.

One of the advocacy groups in the recent EU case states: "we hope that authorities have paid attention to two major drawbacks of the EU investigations: the long-drawn-out process and Google's tactics to use any loophole to avoid changing its business model

So... what's the SOLUTION?

One of the more innovative approaches I have heard is the idea that regulators in each country should impose a **billion dollars per day** penalty such that Google must post a "performance bond" on a **daily basis** guaranteeing that no such illegal activity shall occur in that country **for each and every day**. Of course, if **any** illegal activity detected, Google forfeits the bond for **each and every day** that the illegality is detected and/or perpetuated by Google's antics of delays **retroactively**. Google can of course **avoid** these massive penalties levied by every country in the free world, simply by acting legally and ethically and cooperating with regulators as regulators dig through the **massive piles of evidence of Google's illegal actions** as the worldwide mess created by Google is unravelled and appropriate actions are taken.

If any illegal activity is reported on a particular day, Google forfeits the performance bond and must post another each and every day until the alleged violations have been corrected. If

illegality is detected which occurred 30 days ago, the performance bond applies retroactively all the way back to the first day on which the illegal activity was performed by Google and the **one billion dollars per day fine** applies retroactively for **each and every day Google acted illegally**.

Of course to give the proposal some teeth, the proposal suggests that Google's choice to not post the bond results in **freezing the assets of Google** until the bond is posted for each and every day it has been due given Google's illegal activities. And Google's choice to not post the bond is itself a forfeiture of the bond for each and every day Google delays and refuses to make the payment assessed by the regulatory agency.

Under this proposal, Executives within Google and other big tech corporations who participated in these malicious activities **are operating as criminals** at levels of criminality **far worse** than the infamous Al Capone and are therefore treated as the **inhuman beasts** they have become. Therefore, under this plan, those executives who **choose** to not conduct themselves and the corporations they direct ethically and responsibly and to cooperate with the performance bonds within the plan and/or create unnecessary delays in restoring a level playing field through directed delays shall themselves be subject to **deportation** after all of their assets have been frozen.

Case studies

Any small business or startup website who has been caught up in one of Google's malicious predatory assaults should contact their alma mater or another business school and share your experience and to assist in efforts to develop multiple case studies regarding Google's malicious conduct.

Google is a substantial **contributor** to Stanford, and so perhaps the likelihood of Stanford embracing a case study about Google's illegal conduct could be quite low, but many well-respected business schools across the nation will jump at the chance to accurately document Google's practices that reach far outside any reasonable standard of law and order.

Two years ago, I started sharing my experiences about malicious assaults by Google. When it first started close friends asked me "Why would Google do this?" And to be honest, I wondered the same thing myself.

Two years after it started, now that we have seen in the aftermath no less than \$10 billion in fines levied against Google by regulators worldwide, and **100% certainty** that many more fines will be levied against Google for its illegal, monopolistic, and predatory practices, and now having observed that no less than 49 state attorney-generals have joined lawsuits against Google for its anti-competitive and monopolistic practices, as well as the European Union and China, and India each levying substantial fines against Google, plus a whole host of other levies against YouTube, no one really wonders **whether** it's happening anymore.

The question now is simply how **far** is Google willing to go. I recently asked regulators this same question. What will it take to get regulators to put a stop to these malicious activities? Can Google **kill** without fear of regulatory reprisal?

Google can afford to pull all of its shit of course because of the power and financial strength it has gained through the slough of anti-competitive, predatory, and illegal practices against the rest of the world. The longer Google is allowed to perpetuate these activities, the worse it is for consumers and the worse it is for free competition as it funds the **war chest** for Google to perpetuate the legal efforts to fight and delay every decision.

Google has **designed and built and implemented** its Google-centric anti-competitive features into the Android phones it offers, and now builds them into the phones offered by large ISPs and phone and/or carrier corporations such as COMCAST and tMobile to consumers at very low monthly rates.

These new “cheap” phones are being offered en masse at ridiculously low prices (and “cheap” only applies if you consider Google’s ability to track everything you do, know everywhere you go, see everything you buy, and present to you **ONLY** Google’s own options for purchase all of no value). The clear purpose of offering these cheap phones is maintain a stranglehold on consumer behavior tracking and maintaining its consumer influence share now that Google itself is being **ordered** to stop embedding the tracking codes in its browser and to stop lying that it didn’t/doesn’t ever do it.

Remember also, due to the introduction of DNS 1.1.1.1, combined with the federal order **requiring** Google to remove the tracking codes from its browser, Google and many large ISP’s are losing their ability to track user behavior. ISP’s have **delayed as long as possible** rolling out the required adoption of the DNS 1.1.1.1 standard simply because they earn a LOT of money by tracking and selling the user behavior. Imagine how much Google really makes by tracking and selling all your information. Do you really wonder why COMCAST is suddenly offering a nationwide \$30/month phone plan.? Stop wondering.

Don’t be fooled. The words of CEO John Cook from Apple should resonate in the ears of each and every person around the world until the strangleholds Google has created on free markets are released. That occurs when Google’s ability to block, manipulate, and interfere with the normal activities of free markets are CEASED, which of course requires Google to implement tracker-free searching, and tracker-free user online behavior and tracker-free offline behavior (including movement), as well as **implementation of 1.1.1.1 by default in all Android devices**, instead of Google DNS which enables Google to track every site you visit as well as that tracking perpetuated by shady ISP’s not deploying the 1.1.1.1 standard:

We can easily deduce that that massive number of requests (7.2 million) in a 5 hour period were submitted by Google. Google latest request for inclusion in their search index is is that our pages have business identifying information, such as business name, address, city, state, zip, phone, email. We submitted that information for 1.2 million pages on our site this past weekend. The obvious outstanding question is whether Google will FINALLY and ethically include our pages according to its own rules in its results.




If it can get away with it, Google will refuse to obey its own rules for page inclusion in its search results in favor of its “preferred partners” where it shares a portion of revenue with the partner.



If it can get away with it, Google will block its Android devices from loading a website's pages once that site has been placed on Google's **targeted-for-destruction** site list.
